Sub:- Ease of Doing Business Reforms- Implementing online system for Registration and Renewal of License under Legal Metrology Act 2009, Risk categorization of weights and measures articles and institutionalize Central Inspection System orders issued-Reg.

The Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce & Industry, Government of India, New Delhi has communicated the State Reforms Action Plan (SRAP), 2020 and District Reforms Action Plan 2020 as follows:

NOTIFICATION

Under rule 30 of the Telangana State Legal Metrology Rules (Enforcement) 2011, the following notification is issued:

1. Certificate for Verification of Weights & Measures and its renewal

The Controller of Legal Metrology Telangana, Hyderabad in compliance to District Reforms Action Plan and State Reforms Action Plan mandated that all applications related to weights and measures are to be submitted only by visiting department website "<http://lm.telangana.gov.in/home.do>".

Under this, there will be no physical touch point for the activities such as Application submission, Payment, Tracking and Monitoring of the application. The user will be able to download the final signed approval certificate from the online portal through his/her user login. Procedure, comprehensive list of documents required, timelines and third-party verification are available in the department website. Further, a dashboard will be developed for showing the update on number of licenses/certificates issued periodically.

2. Auto-renewal under the Legal Metrology Act, 2009

- (i) In compliance with EoDB guidelines, the department has herewith decided to auto-renewal of the licenses (Manufacturer/Repairer/Dealer) subject to the payment of annual fee and prompt online submission of quarterly periodical returns as mandated under Schedule VII of Rule 13 of TSLM (Enforcement) Rules, 2011. This service can be availed through TS Meeseva portal (MEESEVA.TELANGANA.GOV.IN as citizen login).
- (ii) The users of weights and measures articles shall login and enter the details of the service report from the valid licensed repairer/manufacture for every weights and measures articles that is due for renewal at least before 30 days of expiry of the verification certificate, subject to the payment of fee prescribed, the verification certificate would be automatically renewed and

generated instantly. The user can download the renewed verification certificate from his user login. This service can be availed through <http://dev88.cgg.gov.in/TSLM/initialRegistration.do/>

Annexure-I

The following documents needs to be submitted/uploaded in department portal, for alteration/auto-renewal of the License (Manufacturer /Repairer/Dealer).

1. Copy of Original License issued. If change in Skilled worker other than licensee in the same field. Consent of the individual skilled worker to be uploaded.
2. If change in new address rental deed (if own not applicable, but shall produce the Municipal/Panchayat tax receipt of current year).
3. In case of Manufacturer to add or remove articles of Weights and Measures, if any, in license document, he/she shall upload the relevant document as specified.
4. Maximum time for dispose the application is 30 days.
5. Payment required fee of Rs: 500-00 for each alteration.
6. Copy of last year license issued in last year.
7. Upload four quarterly periodical returns) inspection.

The following documents needs to be submitted/uploaded in department portal, for users of weights and measures articles verification

1. Copy of last year verification certificate issued.
2. Copy of Model approval certificate for the machine
3. Service Report form the valid licensed repairer/manufacturer for every weights and measures article
